# **ABOUT MASTER OF BUSINESS FINANCE**

Master of Business Finance is a course offered by School of Commerce, XIM University for students who seek proficiency in the finance domain. The two-year full-time Master's program is developed with the main objective of churning out fundamentally strong, technically equipped and industry ready business leaders. The course is designed to amplify the business finance skills and enable students to emerge as global business leaders which are fueled by courses on current issues, seminars, workshops and interaction with industry experts.

# **PROGRAMME OBJECTIVES**

The program emphasizes at helping students sharpen their conceptual as well as analytical skills in the areas of financial decision-making.

At the end of 1st year, the students need to take an 8-week Summer Internship Program so as to facilitate the industrial exposure.

The course promotes specialization in the financial domain by increasing the students' capabilities in key areas of finance like commercial banking, portfolio management, corporate finance, investment banking, etc. Due to the rapid change in the industry, the course also divulges in educating students various tools like Python, R, and SPSS.



The two-year program is divided into 4 semesters with the first-two semesters being dedicated for giving inputs to students on fundamentals of finance through classroom sessions on Financial Accounting, Financial Management, Corporate Laws, Economics, Business Statistics and other key areas.

The fundamentals coupled with industrial experience set the foundation for advanced courses like Behavioral Finance, Financial Modelling, Business Analytics and others covered in the next 2 semesters.

# **PROGRAMME DESIGN**

The program is designed to have a sound knowledge of the financial sector and create professionals contributing to those sectors. The program layout is such that it is interactive and strikes a balance between the core technical, financial skills, and business management skills.

# **Classroom Segment**

The main focus of this segment is to expose students to the theoretical and practical concepts of finance that set a platform for advanced learning. The students are often required to carry out research projects in various subjects to be equipped with numerous skills and techniques taught in the class. Along with the research projects, several live projects, case studies, and activities are conducted for the students to implement the classroom learning into the practical field.

# Live Projects & Independent Research

This program is a fine blend of theory and practical aspects, which will make students expand their knowledge and skillset by the end of two years. This program assists the students in working in various research fields and helps teach them the skills to tackle problems and issues in the industry. This program facilitates live projects with financial organizations to simulate the deliverables at the turnaround time of the industry.

# Immersion Courses

Immersion Courses is a unique educational initiative that enables the students to broaden their horizons into uncharted territories and explore newer opportunities. The students are provided with a chance to take up immersion courses that involve leaders and professionals who provide input to the students on upcoming areas in the industry and the sector. Some of the immersion courses include sessions on – Financial Modelling & Business Valuation, Power BI & Tableau, Investment Banking: The Financial Ratio Analysis.

# Summer Internship (SIP)

Summer Internship is eight weeks where the students undergo proper training; they get an opportunity to understand the working ambiance of an organization to gain practical knowledge. It strives to equip the students with more effective technical skills and better decisionmaking abilities. SIPs also help the students develop innovative solutions to the organizations' significant issues, including operational and functional challenges in the organization. SIPs play a vital role in the curriculum and have eight credits for academic evaluation.

# Pre Placement Offers (PPOs)

After the summer internship, a pre-placement offer, or PPO, is a highly coveted employment offer before final placements. The organisation and the student have the chance to evaluate their compatibility with one another after an exposure period of eight weeks. Before the start of Placement Week, the businesses might inform the Institute of their choice to offer PPOs. If the business does not have internal guidelines guiding this procedure, the students' choice will be shared with the business either after Placement Week has ended or at the designated time during Placement Week.


# Job Offers

A job offer is only regarded as legitimate if the placement office receives formal confirmation of it. No verbal or telephone conversation will be taken into consideration as a job offer. Only at the specified days and times will the candidates' final bids be made public. If this is delayed or not done, the candidate may be hired by another business. Within 20 days of the job offer being made on campus, appointment letters for the chosen candidate should be forwarded (in triplicate) to the placement office. By signing their acceptance, the candidate confirms they have received the employment offer, and the concerned employer will be notified right away.




